## 2017 Extreme Tour Season General Waiver

Any applicant, subject to the terms and conditions contained herein, may apply to compete at an individual event or multiple events approved by the 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc. All competitors, production crew, photographers, media personnel, employees contract or otherwise, are subject to the Constitution, By-Laws and Rules of the International Professional Rodeo Association and/or the Ontario Rodeo Association as it pertains to their respective events and may or may not accumulate any points towards said Associations. The 2017 Extreme Tour will accept contestants with current competing year and in-good standing memberships with the said associations. Contestants not holding an association card in any of the aforementioned will be allowed to compete on an IPRA Permit and will pay the permit fee at the competing event to the 2017 Extreme Tour. This waiver applies to each and every event attended by the competitor and produced, managed and affiliated with the 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc.

### RELEASE AND COVENANT

WHEREAS, I, undersigned, desire to compete, appear, be employed, volunteer, or am otherwise involved in rodeos, bull ridings and/or extreme events produced by the 2017 Extreme Tour (herein after referred to as "Rodeos"), the Rawhide Rodeo Company and Rawhide Entertainment Inc.

WHEREAS, I am doing so entirely upon my own initiative, risk and responsibility, and understand that I might be injured and sustain damages to my person or property, and being fully aware that this is a hazardous venture, I agree that I personally assume any and all risks of injury and/or accident and/or damage and/or death arising directly or indirectly from my participation in the Rodeos, and I hereby release the 2017 Extreme Tour, Rawhide Rodeo Company, Rawhide Entertainment Inc, Wild Time Productions, it's owners, operators, any directly or indirectly affiliated Rodeo Associations (ORA, ACEC and IPRA), Executive and Board of Directors, Rodeo producers, management, sponsors, property owners, personnel and anyone connected with the rodeos for damage for an injury or any property damage I might sustain.

AND In consideration of the 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc. permitting me to participate, I, the undersigned, hereby promise, covenant and agree to and with the 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc., its successors and assigns, that neither I nor anyone claiming through me will hereinafter bring, commence, prosecute or maintain or cause or permit to be bought, commenced, prosecuted or maintained, any suit or action either by law or in Equity, in any Court in Canada or any Province thereof or elsewhere against the 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc., its successors and assigns, for or on account of any injuries or any properties damaged arising out of, or in any way connected with, the Rodeos or my participation in said Rodeos.

I further agree to indemnify and hold harmless the rodeo producers, management, sponsors, property owners, personnel and anyone connected with the 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc., and to pay any claims which these parties would be required to pay me, or any other person, who might sustain any injury and/or any property damage as a result of my negligence. The 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc. reserve the right, with consultation of a doctor or qualified paramedic, to bar a competitor from starting or continuing an event.

I, the undersigned, for good and valuable consideration, hereby give permission to the 2017 Extreme Tour, the Rawhide Rodeo Company and Rawhide Entertainment Inc. and/or parties designated by Rawhide Entertainment Inc. to photograph myself and use such photographs in all forms of media, for any and all promotional purposes including advertising, publicity, display, audiovisual, exhibition, commercial or editorial use. I understand that the term 'photograph' as used herein encompasses still photographs, auto recording and motion picture footage. I further consent to the reproduction and/or authorization by Rawhide Entertainment Inc. to reproduce and use such photographs for use in all domestic and foreign markets. I hereby release Rawhide Entertainment Inc. and any of its associates, affiliates, appointed advertising agencies and designated directors, officers, agents, employees and customers from any claims.
